This EPD is generated on the basis of the LCA background report 'Wardrobe shelf system BB23' with the calculation identifier ReTHiNK-145517.

2 Product

2.1 PRODUCT DESCRIPTION

BB23 is a wall-mounted shelf system with wall rails, a shelf, consoles with brackets and a clothing rail for wardrobes, delivered unassembled. The wardrobe shelf system is available in lengths between 1253 mm (1 or 2 sections) and 4412 mm (7 sections). The wall rails and the consoles with brackets for the clothing rail are made of powder-coated steel, the shelf is a lacquered plywood board, the clothing rail is chrome-polished. Steel screws are used to mount the shelf.

The EPD declares an average product of one shelf system with a length of one meter.

The main purpose of the wardrobe shelf system BB23 is to provide storage mainly for clothes. The main customers of the manufacturer are other businesses.

The product in this EPD does not contain substances from the "Candidate list of substances of very high concern (SVHC) for authorization" in concentration above 0.1 %.

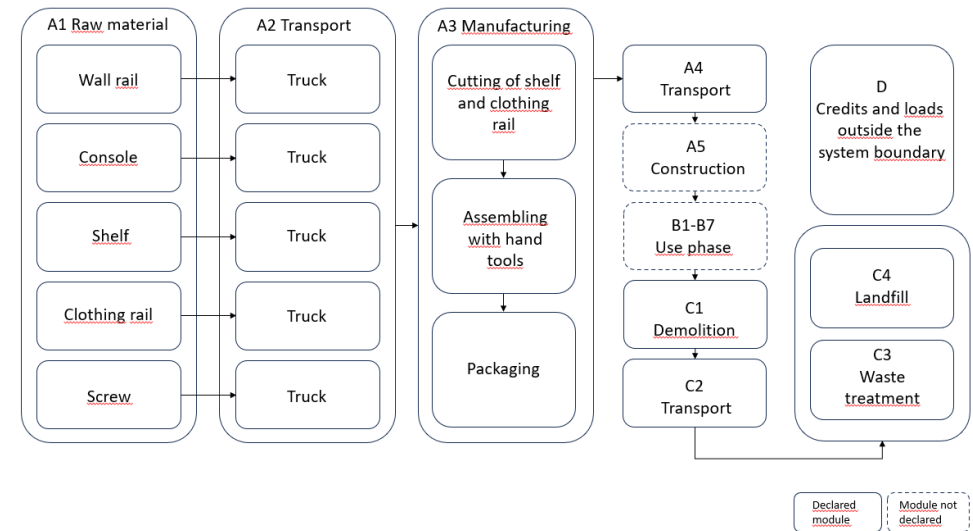
2.5 DESCRIPTION PRODUCTION PROCESS

All raw materials used in the production of the wall-mounted shelf system are transported by truck to the production facility.

The plywood boards have been delivered to the factory pre-finished with a white lacquer coating. The ordered lengths are cut to size, and the edges are beveled. Any areas with insufficient lacquer coverage are retouched to ensure a uniform finish. The chromed clothing rail is cut to size and the ends are covered with a chromed end-cap.

The wall rails and the consoles with the brackets are supplied to the factory with a powder-coated surface treatment. The required quantity of rails and consoles is collected

according to the order specification. The final product is packaged in an unassembled state for delivery.



2.6 CONSTRUCTION DESCRIPTION

The construction process is carried out by manual labor with hand tools.

3.4 REPRESENTATIVENESS

This EPD is representative for wall-mounted shelf system BB23, a product of Byggbeslag AB.

3.5 CUT-OFF CRITERIA

Product stage (A1-A3)

All input flows (e.g. raw materials, transportation, energy use, packaging, etc.) and output flows (e.g. production waste) are considered in this LCA. The total neglected input flows do therefore not exceed the limit of 5% of energy use and mass.

3 Calculation rules

Construction process stage (A4-A5)

All input flows (e.g. transportation to the construction site, additional raw material use for construction, etc.) and output flows (e.g. construction waste, packaging waste, etc.) are considered in this LCA. The total neglected input flows do therefore not exceed the limit of 5% of energy use and mass.

End of life stage (C1-C4)

All input flows (e.g. energy use for demolition or disassembly, transport to waste processing, etc.) and output flows (e.g. end-of-life waste processing of the product, etc.) are considered in this LCA. The total neglected input flows do therefore not exceed the limit of 5% of energy use and mass.

Benefits and loads beyond the system boundary (Module D)

All benefits and loads beyond the system boundary resulting from reusable products, recyclable materials and/or useful energy carriers leaving the product system are considered in this LCA.

3.6 ALLOCATION

There are no co-products produced during the manufacturing of this product. There are no allocations for the declared modules.

3.7 DATA COLLECTION & REFERENCE PERIOD

All relevant data was collected for the calendar year 2025, January to December.

3.8 ESTIMATES AND ASSUMPTIONS

The calculations have been performed in accordance with the “polluter pays” and “modularity” principles, as defined in EN 15804+A2.

The following estimates and assumptions have been made for this EPD.

The wardrobe shelf system BB23 is available in seven different sections of lengths between 1253 mm (1 or 2 sections) and 4412 mm (7 sections). The mass of materials was calculated by dividing all used materials by all sold BB23 lengths in 2025.

The values for the energy and packaging materials are based on values given by the producer. The energy use for the electric truck and the cutting of clothing rail and shelf has been measured for one piece of BB23. The customer assembles the shelf system by themselves. The packaging consists of two parts: the product packaging and the packaging of the Euro pallet. The amount of packaging for the product is based on one piece of BB23 (1 m). It is assumed that 10 pieces of BB23 fit on a Euro pallet. The packaging for the pallet is therefore calculated as one tenth of the amount given by the manufacturer for the pallet packaging.

3.9 DATA QUALITY

All data that is specific to the product and process was provided by the manufacturer for the operating year 2025 and is therefore up-to-date. The manufacturer and their production are located in Karlstad, Sweden.

Background data was taken from the Ecoinvent 3.9.1 database. The database is regularly checked and thus complies with the requirements of ISO 14040/44 (background data not older than 10 years). The background data meets the requirements of EN 15804.

The general rule was followed that specific data from specific production processes or average data derived from specific processes must be given priority when calculating an EPD or Life Cycle Assessment. Data for processes that the manufacturer cannot influence or choose, were supported by generic data.

The scenarios included are currently in use and are representative of one of the most likely scenario alternatives. According to the criteria of the "UN Environmental Global Guidance on LCA database development" mentioned in EN 15804+A2, the data quality for all three representativeness categories (geographical, technical and time) can be described as good.

3.10 POWER MIX

The energy used is the profile for Sweden's residual mix. The emission factor of the carbon footprint for the applied electricity mix is declared as 0.0786 kg CO₂e/kWh.

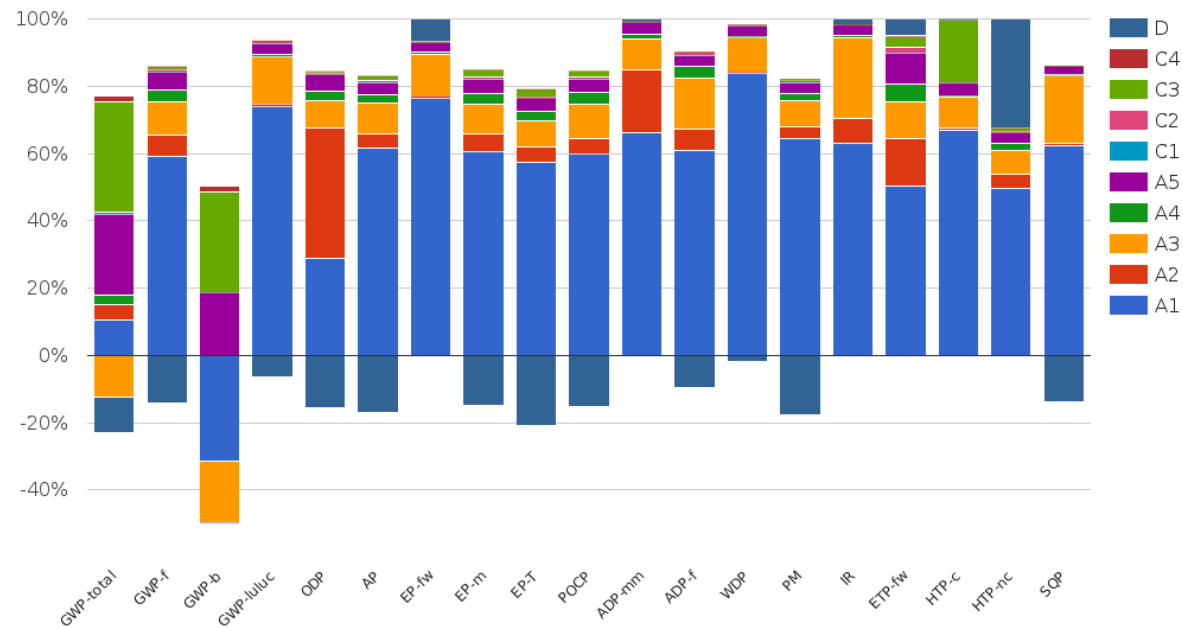

UPTAKE OF BIOGENIC CARBON DIOXIDE

The following amount of carbon dioxide uptake is taken into account. Related uptake and release of carbon dioxide in downstream processes are not taken into account in this number although they do appear in the presented results. One kilogram of biogenic Carbon content is equivalent to 44/12 kg of biogenic carbon dioxide uptake.

The figure shows the influence of the different life stages on the environmental core indicators for the wardrobe shelf system BB23. As shown in the figure the majority of the environmental impacts are contributed by the raw material processing phase (A1) and the production process (A3). The benefits and loads beyond the system boundary (D) have a considerable impact across most of the environmental impact categories (module D is outside the system boundaries).

Modules A5 (installation into the building) - in regard to the packaging materials - and C3 (waste processing) have a considerable impact on the Global Warming Potential (GWP-total). Module C3 has a larger impact than the rest of the end of life stages due to the recycling of the packaging material and metal that in turn affects the phase benefits and loads (D). The recycling of the material contributes to a large part of the module benefits

and loads (D) (module D is outside the system boundaries). The packaging materials (cardboard, EUR-flat pallet) contribute to a biogenic CO₂ uptake.

The modules A2, A4 and C2 (transport of raw materials, transport to the construction site and waste transport), deconstruction/demolition (C1) and disposal (C4) have the least impact on the environmental impact categories.
